## Missouri Hospice and Palliative Care Association 2017 Hospice Statistical Data Reports

Hospice providers in Missouri must complete annually a data report to the Unit of Home Care and Rehabilitative Standards of the Missouri Department of Health and Senior Services. MHPCA's Annual Hospice Statistical Data Reports are compiled based on the information provide by hospice providers. The data is available to MHPCA members in three forms.

<p><b>Electronic Manual</b>—Contains statewide collective data showing statewide counts, percentages, and individual provider reports organized alphabetically by agency. The data pages list the information reported in the annual statistical report. The report does not compare agencies to one another. The data is a valuable tool for hospice providers to evaluate services, patient populations and identify growth opportunities.</p>	<p><b>CD Report</b>—provides access to the data to sort, compare and analyze (i.e. length of stay; average daily census; patients served by county) Two reports are included 1.) Statewide Data in Excel spreadsheet; and 2.) Patients Served report by County in Excel spreadsheet. The disk is a great way to access information on market share by county or diagnosis information.</p>	<p><b>County Report</b>—include patients served and patient death information by county and compares deaths of residents of each county as provided in the Missouri Department of Health and Senior Services Vital Statistics. Report contains hospice admissions/deaths in two forms 1.) alphabetically list of counties; 2.) listing of counties by percentage of hospice death to total death of residents.</p>
